About the Collection

T.F (Thomas Francis) O'Rahilly, born 11th November 1882 in Listowel Co Kerry; was an Irish scholar of Celtic languages particularly historical linguistics and Irish dialects. He became Professor of Modern Irish at Trinity College Dublin in 1919, held the position of National University of Ireland Research Professor in Gaelic Languages (1929-1940), Senior Professor in the School of Celtic Studies at the Dublin Institute for Advanced Studies (1940-1948) and Honorary Professor of Irish in Trinity College Dublin (1952-1953).

He was regarded as the foremost scholar of Modern Irish of the period.

T.F O'Rahilly was also known for his controversial theories on Irish history, bilingualism, and language contact.

Although O'Rahilly's theories were highly influential, many of these theories which have been challenged by linguists, historians and archaeologists are no longer accepted.

T.F O'Rahilly died suddenly at home on 16th November 1953.

This collection consists of a series of correspondence and transcripts.

Of the correspondence can be found, fifteen letters from D.J. O'Sullivan to T.F. O'Rahilly 1926-28 which ask O'Rahilly to act as witness in a libel action taken by the Clandillons against O'Sullivan. Several letters also make reference to MS Bunting part ii, which O'Sullivan has sent to O'Rahilly asking him to read and add suggestions and corrections to the manuscript.

There are also seven letters from George Russell (AE) to T.F O'Rahilly on Irish statesman notepaper 1925-27, dealing with the question of state financial support for Gaelic scholarship, and with the setting up of a fund for the promotion of Irish Studies by Judge H.B Higgins of Melbourne - included is a MS 2pp. memorandum on the proposed administration of the fund signed by O. Bergin, T.F. O'Rahilly, R. Best, and E.J. Gwynn.

Other correspondents include M. O'Cathain (letter in Irish) and Paul Grosjean (letter in French). Correspondence between A. Martin Freeman and T.F. O'Rahilly, and between James Hogan and T.F. O'Rahilly is in regards to translations. There is also a letter to Mr Price from T.F. O'Rahilly pertaining to the publication of 'Onanestus' and discussing a government sponsored Irish Place Names Institute.

In addition, the collection contains typescripts of translations with handwritten annotations.

Letter of thanks, for the corrected manuscript. Invitation issued to visit after Easter when the professor is feeling better. Mention is made of the diary transcription which the professor had advised on. TLS 1p.

Letter stating that the Clandillons intend to pursue the matter through the courts, D.J. O'Sullivan suggests that the two of them meet to see the book together. ALS 3pp.

02/09/1928

Letter stating that the Clandillon case is to be heard next month and he is looking for possible witnesses. He asks the professor about meeting up to look at the book. ALS 1p.

10. 24/09/1928

Cairn Hill, Foxrock, Co. Dublin with "Oireachtas Eireann" stamp. Letter asking the professor to clarify his position re his willingness to give evidence

in the Clandillon libel case. ALS 1p.

11. 01/10/1928

Letter of some urgency. A copy of the book with the more serious mistakes highlighted has been left for the professor to study prior to the court case. He feels that the professor's help is vital for a good outcome. ALS 2pp.

Letter following a brief chance talk with Professor O'Rahilly informing him that the solicitor and counsel think it best if Professor O'Rahilly acts as a witness in the case. Offer for Professor and Mrs O'Rahilly to call on Sunday for tea extended.
