OVERVIEW

This topical postgraduate degree programme in Criminology and Criminal Justice is taught by internationally recognised scholars and researchers who offer students a wide introduction to the study of crime and criminal justice both in Northern Ireland and internationally. Many staff members have a research interest in Northern Ireland's transitional justice arrangements post Belfast-Agreement (1998) in the areas of policing, victims, prisons and restorative justice amongst others.

Queen's offers one of the few criminology programmes anywhere in the world that focuses on the reform of criminal justice agencies as part of a broader peace settlement. Key to this is a consideration of the extent to which criminal justice agencies contributed to the dynamics of conflict in Northern Ireland historically and the lessons that can be taken from this by other jurisdictions. As such, the programme aims to give students an understanding of the key debates in criminology but also to give them an understanding of how and why criminal justice agencies such as the police and prisons can contribute to social conflict and how they can be reformed. Key research strengths of the teaching staff lie in the following areas: community safety and crime prevention; policing; prisoner reintegration; restorative justice, sexual offending, victimology, anti-social behaviour and youth justice.

The LLM in Criminology and Criminal Justice enables students to understand the motivations for offending as well as the practical operation of criminal justice and how the state responds to criminality and victimisation. This degree will be of considerable relevance and interest to those who are already employed in criminal justice related work in fields such as legal practice, government and non-governmental organisations, as well as equipping those who have just completed undergraduate degrees to develop the knowledge and skills to pursue criminal justice-related careers or undertake advanced level study to PhD level.



PROGRAMME STRUCTURE

The LLM Criminology and Criminal Justice programme takes an interdisciplinary approach to the study of crime and justice and draws on original staff research. Modules are rooted in relevant theoretical frameworks with a strong criminological focus and provide students with methodological training in addition to supporting the development of critical analysis and other transferable skills. Through the dissertation, students can explore a wide variety of criminological and criminal justice topics. Students are encouraged to develop a critical understanding of the criminal justice process and the practical operation of criminal law in a domestic and comparative context, and are given the opportunity to explore in-depth a particular criminological or criminal justice-related issue through the submission of a dissertation.

SPECIAL FEATURES

- The LLM in Criminology and Criminal Justice programme is international in focus and taught by leading academics and practitioners in the field. The School of Law also co-sponsors the Institute of Criminology and Criminal Justice (ICCJ), which has strong connections to civil society organisations, criminal justice bodies and agencies, and international institutions and networks. The ICCJ organises an active, annual speaker and conference series, with talks by academics and practitioners.

- Queen's offers one of the few criminology LLM programmes anywhere in the world that considers the reform of criminal justice agencies as a core component of a broader peace-building process. Many teaching staff were actively involved in debates around police and prisons reform that eventually led to the Belfast Agreement in 1998.
- This LLM provides an excellent grounding for those students who want a career in the police, prison service or in some other area that requires specialist criminal justice knowledge and expertise. For example, many NGOs assist those adults and young people serving custodial sentences, while other NGOs deal with victims' rights and alternatives to custody.
- Some Criminology and Criminal Justice graduates use this degree as a base for further study towards a research degree such as a PhD, which may in turn lead to an academic career. Many criminology and criminal justice graduates of Queen's now occupy academic positions across the globe.

OVERVIEW

The LLM International Commercial and Business Law is designed as a research-led programme for graduates from law and related disciplines who aim to specialise in commercial law, international trade and cross-border business transactions from a socio-legal perspective. It will help students understand and master the highly dynamic and complex legal and regulatory regimes governing international business and the global economy. If students aim for a career in corporate, financial or commercial law, our programme will equip them with solid knowledge and an advanced understanding of the key principles, rules and practices in areas such as corporate governance, corporate law, competition law, financial law, and trade law. With support from leading academics throughout this LLM, students will be able to develop a broad set of relevant skills that will allow them to contribute to legal problem solving in key areas of commercial and business law.

Thanks to our diverse staff and student body, students will have a unique opportunity to meet lecturers and peers with different experiences and backgrounds, enabling them to expand their own perspective and understanding further. In previous years students have joined the programme from both the UK and around the world, significantly contributing to the discussions in class and group work.

The School's world-leading academics specialise in a range of relevant areas, including:

- International and Transnational Commercial Law, including international commercial and financial transactions, Conflict of Laws/Private International Law, harmonisation and regionalisation of commercial law, and commercial litigation and arbitration
- International Competition Law, including European and Comparative Competition Law

- International Trade Law, including World Trade Organisation Law, international economic law, dispute settlement, and regional and national trade laws and policies
- Legal Aspects of Innovation and New Technologies, including blockchain and smart contracts
- Corporate Governance and Compliance, including comparative corporate governance and corporate social responsibility
- International Financial Regulation, including regulatory changes in the aftermaths of the East-Asian Financial Crisis and the Global Financial Crisis, regulating finance in key jurisdictions and in global financial centres and tax havens, deepening financial integration and financial fragmentation, the role of law and technology in finance, and the transition to sustainable and digital finance

- The Law School and its academic staff are highly connected with institutions outside the higher education sector, enabling us to provide a programme that is vastly relevant for real-world problem solving. OVERVIEW

The protection of human rights at the international and national levels is a fast-moving branch of law. There has been a huge growth in the number and variety of human rights standards set out in international treaties, in national constitutions, and in other so-called 'soft law' documents. These standards are not always fully implemented and the mechanisms for trying to get them implemented are sometimes defective.

This LLM provides students with an opportunity to gain an in-depth appreciation of global human rights standards and the interrelationship between international standards and national practice. In particular, we consider ways in which human rights could be protected more effectively so that human beings everywhere can realise their full human dignity. The School has more than 25 years' experience in delivering the LLM in Human Rights Law.

PROGRAMME STRUCTURE

The programme is delivered through a series of taught modules and culminates in the submission of a dissertation on an original topic. The School constantly reviews and revises what it offers as part of this degree, changing content to reflect the human rights issues that are currently most prominent.

Human rights research and teaching has been carried out in the School since 1990. In addition to teaching, there is also a thriving Human Rights Centre at Queen's. The Centre has strong links with civil society organisations, statutory human rights bodies and international human rights institutions and networks, and organises a speaker series and a number of conferences annually. It participates in the Association of Human Rights Institutes

and is involved from time to time in the Venice-based Master's in Human Rights and Democratisation. There are extensive links with universities worldwide.

SPECIAL FEATURES

- The School can co-ordinate field visits to institutions dedicated to human rights issues in Belfast, e.g. NI Human Rights Commission and the Equality Commission for Northern Ireland.

- Students are taught by world-renowned academics connected to international, national and regional human rights networks and advocacy. Both staff and students are shaping global and local human rights agendas.

- The School enjoys a unique partnership with the Global Legal Action Network, providing clinical opportunities for law students to work with a qualified solicitor on projects related to prospective litigation.
- Graduates have found jobs in the UN, the EU and the Council of Europe, as well as statutory bodies and a wide range of international and national NGOs. Others have found the LLM to constitute an extremely valuable addition to their work as legal professionals. Furthermore, this Master's provides an excellent base for further study towards a research degree such as a PhD, which in turn may lead on to an academic career.

OVERVIEW

The LLM in Intellectual Property Law delivered within the School of Law is an innovative programme that offers a unique focus on the intersection of globalisation, creative industries, health and life sciences, new technological challenges, and fundamental rights in the field of intellectual property law. The programme will provide students with a general overview of IP law through core modules and a flexible structure, which allows students to tailor their studies to their specific interests and career goals with three major tracks, including IP and global trade, IP and digital tech, global innovation, and public interest. The programme provides a global perspective on the legal issues involved in protecting and promoting intellectual property rights, as well as an in-depth exploration of the ways in which these rights intersect with technological challenges, competing fundamental rights, and IP social function.

Through a combination of coursework, seminars, and practical training opportunities, students in this programme will develop a deep understanding of the legal principles and issues involved in protecting and promoting intellectual property rights in a global context.

This programme is an excellent base for students who wish to find employment as an in-house legal specialist in the high-tech, life science and creative industries or as an IP litigator, patent lawyer, trademark attorney, or licensing executive among other roles. Students may also work in the public sector, advising government agencies on intellectual property law matters or working for non-governmental and inter-governmental organisations focused on intellectual property issues. A broad understanding and an ability to think critically about the field that this programme provides, can also be a great advantage for students who wish to pursue a doctoral degree and a future academic career.

The programme focuses on problem-solving skills that will provide students with the necessary tools to understand how the traditional IP framework should meet unprecedented challenges.

These legal concepts are relevant in many different industries, including high-tech, health and life science, media, fashion, and more. As a result, graduates of an LLM in the IP Law programme have a wide range of job opportunities available to them in various industries and countries around the world (i.e., as an in-house legal specialist, IP litigator, patent lawyer, trademark attorney, or licensing executive).

OVERVIEW

The Masters in Law (MLaw) is an accelerated two-year, full-time (or four-year part-time) postgraduate degree in law. The programme provides students from diverse backgrounds with an opportunity to study the foundational law modules which are required for the academic stage of legal qualification. This means that the degree covers those subjects that are generally regarded as pre-requisites for professional legal studies.

Students planning to practise law in a particular jurisdiction should contact the appropriate regulator in that jurisdiction to confirm that the programme meets its requirements.

PROGRAMME STRUCTURE

The MLaw is offered on a modular basis. To complete the degree a total of 300 CATS points must be obtained. Twelve modules (20 CATS each) must be taken and a dissertation (60 CATS) must be completed. The structure is as follows:

FUNDING AND SCHOLARSHIPS

The School of Law welcomes applications both from students in receipt of a scholarship and from those who wish to self-fund.

Each year a number of scholarships are normally funded by Northern Ireland's Department for the Economy (DfE), and by both the Arts and Humanities Research Council (AHRC) and Economic and Social Research Council (ESRC) through Queen's membership in consortia with other leading UK universities.

The deadline for applications for these scholarships is usually in the January before September intake. In the Autumn of each year, both the School of Law and the wider University host workshops designed to assist candidates in preparing quality scholarship applications.

OVERVIEW

The School of Law at Queen's has a long and distinguished record of achievement in both education and research. Widely seen as one of the leading centres of legal research in the UK, our expertise ranges across both doctrinal and socio-legal work, and includes fields stretching from governance, property law and intellectual property to human rights, European law, and criminology and criminal justice.

Graduate studies, including postgraduate research, are at the forefront of Queen's vision. The £20 million investment in a new School of Law building has created excellent facilities for postgraduate researchers, with access to Queen's Graduate School just minutes away.

PROGRAMME STRUCTURE

A PhD is awarded for original research in a topic chosen by the student. PhD studies may be undertaken on a full-time (three years) or part-time (six years) basis. Research students are appointed a primary and secondary supervisor who will guide them through their research. This independent research is complemented by programmes of training, provided both by the School of Law and by Queen's Graduate School, which is housed in a beautiful converted building just minutes from the entrance to the new School of Law building.
